A 保用提供

華達出入口有限公司為其售出並且在香港註冊的每輛吉利雷達新車依廠方指引提供保用。

B 保用細則

在香港首次登記之吉利雷達新車的保用細則如下:

若汽車是在正常情況下操作及交由華達出入口有限公司維修中心,或其他合資格的獨立車房進行定期保養,請參閱 D 欄。但若干「不受保用之事項」則不在此保用範圍之列(請參閱 E 欄)。

■C 自付原廠零件及配件的保用

- 1) 若零件是依據保用範圍內之規定而更換,該零件可繼續享用按保用細則內 餘下之保用期。
- 2) 若車主自費經華達出入口有限公司購買、安裝或更換之原廠零件或配件,保用由發票日起為期十二個月或20,000公里(以先到期者作準)。
- 3) 如車輛保用期屆滿後,因產品召回而由廠方免費更換原廠零件,所更換零件的保用有效期為由發票日起為期十二個月或 20,000 公里 (以先到期者作準)。
- 4) 如在保用表中的耗材零件(例如電池、輪胎等),不論是由車主自費或由廠方免費更換的原廠零件,該零件的保用為由發票日起為期三個月或5,000公里,以先到期者作準。

D 車主之應有責任

- 保用期内,廠方建議車輛最少每行畢 20,000 公里或十二個月(以先到期者作準),請車主安排車輛交由華達出入口有限公司或其他合資格的獨立車房接受定期維修檢查。
- 2) 由於廠方針對車輛不同部分有可能出現之損毀或損耗制定了合適的維修方法,為保證車輛維修後的安全性能,廠方建議車主將車輛送往合資格的維修中心或車房進行維修工序。

■E 不受保用之事項

- 1) 所有定期檢查服務及一般維修保養服務,包括(但不止於):冷卻系統清理、制動系統及輪距調校、輪胎平衡及四輪定位、檢查及調整各部件接駁情況等所涉及之人工及零件。
- 2) 所有因車輛使用不當,疏忽或意外造成之損毀,例如(但不止於): 車輛儲存不適當、用作賽車、超重負載、自行改裝、更改汽車規格、擅加配件、不適當調校或修理、採用非原廠或不符合標準規格之零件、及保養不當或缺乏適當保養而導致需要維修、替換零件或其他調整項目之費用。
- 3) 計程表之里數曾遭更改,或與原本行程里數不符合之車輛,而導致的任何維修或零件更換之費用。

- 4) 若動力電池因以下原因導致損壞或故障:
 - 暴露於極端溫度環境
 - 高溫: 車輛暴露於 50°C 以上環境超過 15 天
 - 低溫: 車輛存放於 -30°C 以下環境超過 15 天
 - · 動力電池完全或接近無電狀態下,車輛閒置超過 15 天未使用
 - · 故意破壞(如撞擊、穿刺)導致電池壽命縮短
 - · 未按《車輛說明書》執行正確充電步驟(例如未使用指定充電模式)
 - · 使用不相容的充電設備
 - · 在未取得廠方許可下, 自行拆解或維修動力電池外殼
 - · 電池容量隨時間和使用逐漸下降 (屬正常老化現象,不屬保用範圍)

上述「不受保用之事項」需另行收費。

「首一千公里」免人工檢查服務

華達出入口有限公司特別為每輛出售之新車提供「首一千公里」免人工檢查服務。該項服務按廠方建議之程序進行,及必須在車輛行駛里數達 1,000 公里之前或首次登記日起計四個月內享用(以先到期者作準),不作任何延期。

WARRANTY FOR NEW GEELY RIDDARA VEHICLE

A WARRANTOR

Watek Trading Company Limited warrants each new GEELY RIDDARA vehicle sold by Watek Trading Company Limited and registered in Hong Kong will be provided factory warranty under the factory warranty guideline.

B COVERAGE OF WARRANTY

New GEELY RIDDARA vehicles sold by Watek Trading Company Limited and registered in Hong Kong will be provided with the following warranty coverage:

Provided if the vehicle is being operated under normal way, and with proper and regular maintenance carried out by Watek Trading Company Limited Service Centre, or by other qualified independent workshops at fixed intervals, as specified in Part D. But items listed under "What is Not Covered" as specified in Part E are not included.

C GENUINE PARTS AND ACCESSORIES WARRANTY

- 1) Genuine parts or accessories sold and installed by Watek Trading Company Limited will enjoy a warranty period of 12 months or 20,000km (whichever comes first) commencing from the date of invoice.
- 2) For replacement of parts under warranty, warranty period will persist for the remaining warranty period.
- 3) If a part is replaced with a genuine part free of charge due to product recall after the expiry of the vehicle warranty, the warranty for the replacement part is valid for 12 months or 20,000 km from the date of replacement, whichever comes first.
- 4) If a wearing part (e.g. battery and tyre) in the warranty schedule is replaced with a genuine part at the owner's expense or by Manufacturer free of charge, the warranty for the replacement part is valid for 3 months or 5,000 km from the date of replacement, whichever comes first.

D MAINTENANCE OF THE VEHICLE

- 1) Owners are recommended to send their vehicles to Watek Trading Company Limited Service Centre or other qualified independent workshops for servicing within the warranty period, at least every 20,000km or every 12 months, whichever comes first.
- 2) Since appropriate repair methods for each type of damage on GEELY RIDDARA vehicles has been developed by Manufacturer, in order to guarantee the safety features of vehicles after repairs, any repairs should be carried out professionally. It is recommended that owners use qualified service centres/workshops for repair purpose.

E WHAT IS NOT COVERED

1) The cost of labour and parts under routine and general maintenance services, including (but not limited to) cooling system cleaning, brake adjustments, wheel alignment and balancing, inspection and adjustment of linkages of various parts.

- 2) The cost of repair, replacement of parts or other necessary adjustment arising out of misuse, neglect of or accident to the vehicle, including (but not limited to) improper storage, racing, overloading, modification, alteration, improper adjustment or repairs, the fitting of non-standard parts or parts not supplied by Watek Trading Company Limited, non-genuine parts, and improper or inadequate maintenance.
- 3) The cost of repair or replacement of parts in case of a vehicle on which the odometer mileage reading has been altered or where the mileage of the vehicle cannot readily be ascertained.
- 4) Damage or failure of the power battery due to the following reasons are not covered by the warranty:
 - Exposing the vehicle to an ambient temperature higher than 50°C for more than 15 days.
 - Storing the vehicle in an environment below -30°C for more than 15 days.
 - Allowing the vehicle to remain unused for over 15 days when the power battery is fully or nearly depleted.
 - Physical or intentional damage to the power battery resulting in a shortened battery lifespan.
 - Failure to follow the correct charging steps specified in the Owner's Manual.
 - · Using incompatible charging equipment.
 - Unauthorised opening or repairing of the power battery casing without Manufacturer's permission.
 - Gradual reduction in battery capacity over time, which is not covered by the warranty.

Extra charges will apply for items under "What is Not Covered".

LABOUR-CHARGE FREE INITIAL 1,000 KILOMETER INSPECTION SERVICE

All NEW GEELY RIDDARA vehicles sold by Watek Trading Company Limited are entitled to a labour-charge free initial 1,000 kilometer inspection service. This inspection service will be performed in accordance with the procedures as specified by the Manufacturer and must be redeemed within 1,000km or 4 months from the date of vehicle registration (whichever comes first) and no extension will be granted under any circumstances.

Note:

- 1) All terms and conditions are subject to change without prior notice.
- 2) In case of any discrepancy between the Chinese and English version, the English version shall prevail.


