2-Year Plan: Entitlements to 2 times of the following services in 24 months, effective from the date of purchase of this Plan:

Terms and conditions of 24-hour free towing service 免費24小時拖車服務細則：

- This towing service is only applicable to vehicles being driven in Hong Kong Territory to be towed back to Vang Lek's service centre in Hong Kong; towing service will not be provided at restricted area / closed area / closed road. 此拖車服務只適用於香港境內行駛的車輛被拖回香港宏益維修中心；拖車服務不適用於限制區/禁區/封閉道路。
- The validity of this 24-hour free towing service will expire on the same date of 2-Year Plan. (i.e. 24 months from the commencement of the Plan). 此 24 小時拖車服務有效日期與2年保養服務計劃相同（即計劃有效期為合約生效日期起 24 個月後終止）。

Terms & Conditions 條款及細則

- The Plan is only applicable to vehicle aged over 6 months. 此計劃只適用於車齡滿6個月以上之車輛。

- If a car accident takes place and the Vehicle is damaged to a condition beyond repair (total loss), then any unclaimed entitlements and the remaining period can be transferred to the same model of vehicle belonging to the same registered owner of the Vehicle subject to payment of an administration fee of HK\$500.00. 如該車輛因意外而報廢導致不能繼續使用，本公司同意將餘下年期及服務次數，轉至同一車主名下相同車款之車輛，本公司將收取行政費用港幣\$500。
